Augmented Protocols

1. All patients will complete and sign the AAO Wellness Screening Form before entering the office. If patient is a minor, then the form must be completed and signed by a guardian. The AAO Wellness Screening Form will be posted on our website and Facebook page. Additionally, we can email it upon request and we'll have hard copies at the office. The completed form can be submitted in person when you come to office for your appointment OR it can be emailed before your appointment. **WE'LL BE UNABLE TO KEEP YOUR APPOINTMENT IF THE FORM ISN'T COMPLETED AND SIGNED.** If emailing form, please use the following email address pertaining to your office location:

2. **Only patients are allowed in the office.** If you have questions about your child's treatment, please call our office.
3. We ask that all individuals entering the office please wear a cloth or surgical mask. Please keep your mask covering your nose and mouth at all times other than when we're working on your teeth.
4. We're taking the temperature of anyone entering the office. If your temperature is 100.4°F or higher, then we'll kindly ask that you reschedule your appointment.


5. All restrooms and brushing stations will be closed. Therefore, please brush your teeth before coming to your appointment.
6. Our waiting room will be closed. Thus, please call or text office from your car when you arrive at the office.
7. To prevent congregating around reception area, we won't schedule your next appointment in the office. Instead, we'll call you shortly after your appointment is finished to schedule your next appointment.
8. All patients will use hand sanitizer when entering and leaving office.
9. We're practicing *social distancing* in the office. Therefore, we'll only use clinic chairs that are at least 6 feet apart. Thus, our patient volume will be decreased compared with previous patient volume.
10. Our assistants will be taking extra disinfection/sterilization precautions throughout the office.
11. **We've increased Personal Protective Equipment (PPE) measures. Please see below for more details.**
 - Our entire office team will be wearing a full set of scrubs (tops, pants) and clinic gowns that will be laundered each day. Additionally, our entire team will be wearing masks.
 - For aerosol-producing procedures, our clinical team will be wearing N95 (or equivalent) masks and face shields, using high volume evacuation (HVE), and utilizing additional air filtration units.
 - For remaining procedures, our clinical team will be wearing face shields, surgical masks, and gloves.
12. We'll have acrylic/plastic barriers at the front desk.
